Sprinkler tank at Pirelli's. Agreed but can the application include a landscaping clause and have trees planted outside the chain link fence to screen the tanks from the road. Or could the tank be longer and lower then it would be mostly obscured by the hedge. Mr Allison & Mr Child will look at the site before a response is submitted.

Extension to school for kitchen, agreed.
